Somerton Cemetery, Behind Berry

Fees, Payments and Sums fixed and settled under the Local Authorities Cemeteries Order 1977 (No 204).

The fees, payments and sums are applicable where the services of a Funeral Director are used for the burial arrangements. The fees, payments and sums set out below apply where the person to be interred, or in respect of whom the right is granted was immediately before his or her death, an inhabitant or parishioner of the Parish of Somerton. The charges apply to residents of Somerton, including residents who have recently moved out of Somerton to a nursing home/hospital or to stay with a relative, for a period not exceeding 10 years.

In all other cases the fees, payments and sums will be doubled*. The exception is those fees set out in Part 3 will not be doubled.
